Section 4. First aid measures

Description of necessary first aid measures

Eye contact : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Get medical attention if irritation occurs.

Inhalation : Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if symptoms occur.

Skin contact : If hot wax strikes the skin, drench or immerse the area in water to assist cooling. If available, apply ice water or ice packs to the burned area. (Do not use iced water or cold packs if the burned area covers more than 10% of the body, as this may contribute to shock.) Do not try to remove wax from a burn after it has cooled. Seek medical attention. If cool wax contacts the skin, wash the area with soapy and water. Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Get medical attention if symptoms occur.
